Our Procurement Timeline

1. Purchase Order Received: The procurement process begins with the receipt of a purchase order from the client.
2. Order Confirmation: After receiving the purchase order, Scot Global confirms receipt and sends an order confirmation/quotation to the client, including the expected delivery date.
3. Production and Fulfillment: Scot Global's partners produces and prepares the goods for shipment, following any necessary quality checks and packaging requirements (does not apply to in-stock items).
4. Shipment: Once the goods are prepared, Scot Global arranges for shipment with the carrier or logistics provider and provides the client with updates of the freight whether this be by air, sea or ground.
5. Delivery: The carrier delivers the goods to the client's specified location, and the client receives and inspects the goods to ensure they meet the order requirements.
6. Invoicing and Payment: Scot Global sends an invoice to the client for the goods and any associated fees. The client reviews and approves the invoice, and payment is issued according to the payment terms agreed previously.
